Exploring Synergies and Opportunities in African-Swiss Science Diplomacy

Background

The Swiss Tropical and Public Health Institute (Swiss TPH), the Swiss Commission for Research Partnerships with Developing Countries (KFPE) and the University of Johannesburg are conducting a study that seeks to provide insights into the African Science Diplomacy ecosystem and avenues for bilateral cooperation between African countries and Switzerland. The study is supported in this effort by the Swiss Agency for Development and Cooperation (SDC) and the Swiss State Secretariat for Education, Research and Innovation as well as the South African Department of Science Technology and Innovation and the Human Sciences Research Council.

The study will provide broad and deep insights of the Science Diplomacy situation in Africa. In a first step, all major Anglophone and Francophone countries are screened for explicit Science Diplomacy components; in a second step, a few selected countries with a high level of activity, will be assessed in detail for Science Diplomacy activities (**country case studies**). The study is running throughout 2024 and its primary aim is to enhance the mutual knowledge of the Science Diplomacy ecosystems in Africa and Switzerland and to strengthen bilateral exchanges between the African and Swiss Science Diplomacy communities.

The overall aim of the study is composed of four specific objectives:

- 1. To describe Science Diplomacy strategies, instruments and actors and assess the Science Diplomacy objectives and priorities in selected African countries
- 2. To identify hotspots of Science Diplomacy in Africa
- 3. To analyse bilateral Science Diplomacy initiatives between Switzerland and selected African countries, delineating their characteristics, mutual benefits and identify opportunities and obstacles and the means to overcome them
- 4. To start discussions on the value of an African Science Diplomacy framework

The Objective of this workshop series organized by KFPE and Swiss TPH is to contribute towards overall study objective (3), analysing bilateral Science Diplomacy initiatives between Switzerland and selected African countries. This includes the **special role of SDC** since the agency is operating at the intersection of development and innovation across Africa.
